Multi-disciplinary team

Core objectives

- improve intelligence about how the family justice system is working
- demonstrate the value of data harmonisation and data linkage within the family justice system
- increase capacity and capability of researchers/data analysts to use population-level family justice data
- increase the capacity of policy and practice stakeholders to understand, interpret and apply data




Multiple questions can be answered about Welsh families in public and private law cases using linked data – before, during and beyond family justice involvement. For example

- Health, wellbeing and educational characteristics and outcomes of children in public and private law cases
- Health service utilisation of children and adults
- Broader life chances of children involved in public and private law
- Physical and mental health of adults








#### **Cafcass data (main tables)**
